### b. Jefferson Relief Sewer

Mr. Walby reported the SEMSD has applied to the Michigan Clean Water State Revolving Fund (CWSRF) programs in September, 2022, for the Martin Drainage District for adding a twin pipe at Rio Vista to Nine Mile Road. The preliminary costs are \$25 to \$30 million. The SEMSD is working with Macomb County Public Works Office along with our State Legislatures and Senators to see if we can get additional funding on this project. At this point we need to do some engineering to move forward. The AEW will prepare and submit project plans planning documents for the CWSRF on behalf of the SEMSD. The project services will include preparation of the draft project plan planning documents, complete a hydraulic analysis and report documenting project benefits based on annual reduction in RTB discharges for various storm events. AEW will submit and review draft project plan with EGLE, coordinate with EGLE and preparation and submittal of final project plan planning documents. The fees will be on an hourly basis, not to exceed \$13,000.00.

## c. GLWA FY24 Wholesale Sewer Charge

Mr. Walby noted just received is the GLWA FY24 Wholesale Sewer Charge. The estimate is 2.81%. The GLWA Board will vote on February 22, 2023. No changes in shares, the SEMSD is 5.291%. The shares are done over a 7-year average. Mr. Walby pointed out the Detroit ownership adjustment providing money back to Detroit for tax free property. No Highland Park debt.

### d. General Updates

Mr. Walby reported as part of the SEMSD renovations, a mandatory walk through for the contractor was provided this morning. Bids are due February 8<sup>th</sup>. Attending today were 7 general contractors and several sub-contractors. Some of the contractors had concerns that the existing building will remain standing while the new building is being built. There won't be enough room on the property for their equipment. The SEMSD staff was planning on staying in the existing building while the new building was being built. It would be costly to relocate the staff.

Mr. Walby explained the DTE electrical pole on the SEMSD property needs to be relocated. Due to Spring/Summer weather the pole needs to be moved by April 1, 2023. The new location will be on the property line by the Civic Arena. Payment to DTE for the relocation of pole is \$27,346.04.
