New Business

Director of Operations

The Operations and Administrator update was provided by Kip Walby and Pete Trombley.

Titan Wealth Update

Kevin VandenHaute and Mark Mueller from Titan Wealth Advisor presented the SEMSD 1st Quarter 2023 update. A total of 29 CDs invested totaling \$7.221 million. Estimated yield 2.71%. Estimated annual interest is \$175,420. Treasuries of approximately \$4 million with an estimated yield of 4.75%. Annual revenue of about \$330,000. Mr. VandenHaute explained over the course of 15 months we have a lot maturing almost \$7 million. Currently in a good cash position and we can flip and turn most of the CDs that are maturing at a significant yield of 5% range. In the 3rd quarter, \$3 million matures. No cash is needed so we can stay aggressive with short-term treasuries. Mr. VandenHaute explained we went to a 70/30 allocation for the Pension and Healthcare, and we are at a half percent on every asset class of the target. Overall portfolios are up 5% for the 1st quarter.

<u>Public Hearing on intent to Apply for a Loan from the Clean Water State Revolving Loan</u> <u>Fund for the Jefferson Relief Sewer</u>

Chairman Taylor asked if anyone from the public would like to address the SEMSD Board regarding the Public Hearing on intent to Apply for a Loan from the Clean Water State Revolving Loan Fund for the Jefferson Relief Sewer.

There being no one from the public, Chairman Taylor asked for a motion to close the public hearing.

Mr. Seidel reported Michigan Department of Environmental, Great Lakes and Energy (EGLE) requires everyone present to sign their name with email to the account who is present and receive the final draft. Mr. Seidel presented the Clean Water State Revolving Fund Loan Project Plan (CWSRF)-Jefferson Relief Sewer. The SEMSD is applying for a SRF loan. Mr. Seidel went through the presentation summary of the overview of the CWSRF program including the SEMSD sewer system, the problems to be addressed with this application, the proposed alternative, schedule, financing, cost of project and social and environmental impacts. The CWSRF is offered through EGLE and due May 1, 2023. Projects are scored and placed into a draft priority list in September, 2023. The State Revolving Loan offers a low-interest loan to be established in October/November 2023. Mr. Seidel went through the SEMSD sewer system including the combined sewer system, retention treatment basin (RTB) and pump stations. The purpose of this project is to reduce the RTB volume discharge to Lake St. Clair. The average discharge over the last 13 years for the Chapaton RTB is 7 and for the Martin RTB is 8. There are several alternatives that the SEMSD Wastewater Master Plan looked at such as the 8 1/2 mile in-system storage and the Martin Drain in-system storage which is currently under construction along with the Chapaton Treatment Canal. Mr. Seidel explained the recommended alternative is to construct a new 60-inch Jefferson Relief Sewer between the Martin and Chapaton RTB. The estimated construction costs are \$28.2 million. The next step after submitting the SRF Planning documents to EGLE on or before May 1, 2023 is an RFP for Quality Based Selection of a Design Engineer. Mr. Seidel went over the cost of the project. Mr. Seidel went through the short term and social impacts, the long-term impacts, and the environmental impacts. Mr. Seidel requests any questions or comments from the public.

The City of Novi did not have anything negative to say about CSM Mechanical, LLC. AEW believes CSM Mechanical is qualified and capable of completing the work included in this project.
